GENERAL INFORMATION

These is an ASCA sanctioned trial and all ASCA rules apply (www.asca.org). Dogs over 6 months of age must have proof of ASCA registration available. CASA, the Course Director and club members assume no responsibility for any loss, damage or injury sustained by any exhibitor, handler, dog, property, children or spectator. All dogs must be crated or leashed except while competing.

Entry fees will not be returned if the trial cannot be opened or be completed due to riots, civil disturbances, acts of God, public emergencies or other events beyond the control of CASA. Entry fees will not be refunded if the dog is absent, disqualified, excused or barred from competition by the Show Committee, ASCA, show veteringrian or the judge.

All entries must be on the official ASCA entry form with proper fees included. Exhibitors are responsible for the accuracy of the entry and the class entered. Withdrawal of entries will be accepted until the pre-entry closing date. Returned checks do not constitute a valid entry and there will be a \$38.00 service fee on all returned checks. Entry into future shows/trials and participation in this show/trial will not be allowed until all fees are paid in cash or money order.

Information: Substitutions are allowed providing the dog is owned by same owner. Draw for run order will be after trial registration closes. Bitches in heat will run in order of draw, but must be crated and exercised away from the competition. All breeds recognized by ASCA as herding breeds are eligible to enter the trial.

Stock to be used: 10 head of Dorper/Katahdin cross sheep. Owners of dogs will be responsible for all injuries to livestock; replacement cost per sheep is current \$500.00.

You are responsible to be on site for your runs.



- TP, through Gate 1 (G1) into arena, fetch/drive (f/d) to chute.
 f/d thru chute, into trailer, close door
- unload, thru OB1 to G2
 thru G2, f/d around cone to G3 6. Thru G4 to G5 5. thru G3 to G4
- 7. Thru G5 into pen 1, to G6 8. Begin SORT, sort 3 sheep into Pen 2
- 9. gather all sheep back to Pen 1 10. Thru G8, f/d to Exhaust
